The Oregon District Attorneys Association is pleased to offer a new DUII trial skills workshop for prosecutors that will focus on improving trial techniques, from **June 19-21, 2012** in Salem, Oregon. We have added this training, under our grant from the Oregon Department of Transportation, to work on best practices in trial and to enhance performance in the prosecution of Driving under the Influence of Intoxicants cases.

This 2 ½ day training will allow you to concentrate on trial skills, providing you with tips and techniques used by seasoned prosecutors throughout the trial process. There will be less classroom and the emphasis will be on performance, with feedback from presenters with proven records of success in DUII trials.
